The information we require in your references is as follows;

- The persons providing you the references must have known you for at least two (2) years.
- References will be deemed unacceptable and rejected if the reference is from a relative of the applicant, or living at the same address as the applicant.
- The persons offering you the references must be aged over 18 years, of good standing, and held in high repute in the community.
- The persons providing the references must supply both their own and the applicants full name, address, phone numbers, and email address.
- The references must be addressed by the providers to The Secretary, SSAA Bundaberg Branch Inc.

Please Note

Extract from Weapons Act 1990 Part 4, Division 4, Section 98B

Membership of approved pistol clubs

- (1) It is a condition of an approved pistol club's shooting club permit that the club must not accept a person for membership of the club unless the person submits with the person's application for membership—
 - (a) if the person is not a licensee, a current statement in the approved form signed by an authorised officer that the person is a fit and proper person to hold a licence; and
 - (b) 2 character references from persons the person has known for at least 2 years; and
 - (c) a declaration that the person is a current member of other named approved shooting clubs or that the person is not a current member of any other approved shooting club.
- (2) A statement mentioned in subsection (1)(a) is current for 3 months after the day it is signed by the authorised officer.
